##### Objective

The Fund's investment objective is longer term capital growth principally through diversified investment in Japanese equities and related instruments.

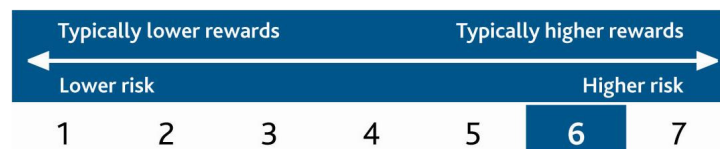
##### Investment Policy

The Fund seeks to achieve its investment objective by investing in the equity securities of companies listed, or regularly traded on, a Japanese stock exchange. The Fund may also retain amounts in cash or cash equivalents pending reinvestment.

##### Essential features of the fund:

- The fund has the discretion to invest in a range of investments as described above with no need to adhere to a particular benchmark.
- You can buy and sell shares in the fund on each business day.
- This share class aims to distribute available income every six months.
- Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.
