Objectives and Investment Policy

Objective

The Fund's investment objective is longer term capital growth principally through diversified investment in Japanese equities and related instruments

Investment Policy

The Fund is actively managed and seeks to achieve its investment objective by investing in the equity securities of companies listed, or regularly traded on, a Japanese stock exchange. The Fund may also retain amounts in cash or cash equivalents pending reinvestment.

Essential features of the Fund:

- The Fund is considered to be actively managed in reference to TOPIX Net Total Return Index (the "Benchmark") by virtue of the fact that it uses the Benchmark for performance comparison purposes. Certain of the Fund's securities may be components of and may have similar weightings to the Benchmark. However the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark.
- The Investment Manager has discretion over the assets held within the Fund. Investments are selected purely on the basis
- of whether they meet the Investment Manager's criteria of identifying strong but undervalued Japanese equity securities with no reference to specific sectors or indices.
- The Fund uses currency forward contracts to hedge the exposure of the base currency of the share class against the Yen denominated assets.
- You can buy and sell shares in the Fund on each business day.
- Income from the Fund will be added to the value of your investment.
- Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and reward profile



- This indicator shows how much a Fund has risen and fallen in the past, and therefore how much a Fund's returns have varied. It is a measure of the Fund's volatility. The higher a fund's past volatility the higher the number on the scale and the greater the risk that investors in that fund may have made losses as well as gains. The lowest number on the scale does not mean that a fund is a risk free investment.
- The Fund has been classed as 6 because its volatility has been measured as high risk.
